SPORT HISTORY PROJECT (SHP) GRANT 2023-2024

The Sport History Project (SHP) Grant is the envy of the sport heritage community in North America.

Unique to Saskatchewan, this grant allows organizations to capture and record, through a variety of means, the sport history of our province. Since its inception in the late 1980's the SHP has funded more than 40 publications, eBooks (both dedicated and produced in support of the print publications), and productions/exhibits. In addition, it has funded a number of archival management projects including the University of Saskatchewan Huskie Athletics archival collection and Special Olympics Saskatchewan archival holdings.

This year the Sport History Committee was made up of the following individuals: Kelvin Ostapowich, Robb Elchuk, Amber Day, Cary Wessel, Don Gallo, Don Steponchev and Erin Stankewich.

At the beginning of the 2023-2024 year, there was one active SHP – The Saskatchewan Games 50-year history project, which worked through and completed Phase II on their overall project. Two new projects came online from Waterski Wakeboard Saskatchewan and SASKI- Para Adaptive Snow Sports.

2023-2024 Project Activity is as follow:

- The Saskatchewan Games Council (SGC) submitted their final Phase II Report which
 outlined projects such as: exhibit development, digitization/archive projects, and full-length
 video documentary project. They received partial funding for Phase III which includes
 website development and updates to be launched with the 2024 Saskatchewan Summer
 Games.
- SASKSKI SASKI- Para Adaptive Snow Sports Phase I funding was awarded to go towards
 interviewing between 30-40 individuals who were involved in the history of adaptive sport
 within the SASKI organization. The goal is to collect stories and documentation of
 improvements and developments, accolades, and historical documents to develop a printed
 book.
- Waterski Wakeboard Saskatchewan Phase I funding was awarded to gather, collect, and digitize stories, artifacts, and records to develop a centralized repository of the history of Waterski and Wakeboard in Saskatchewan, with the goal of building out a website and 'travelling exhibit' of banners and other information.

GOVERNANCE COMMITTEE REPORT 2023-2024
