SPORT HISTORY PROJECT (SHP) GRANT 2024 - 2025

The Sport History Project (SHP) Grant is the envy of the sport heritage community in North America.

Unique to Saskatchewan, this grant allows organizations to capture and record, through a variety of means, the sport history of our province. Since its inception in the late 1980's the SHP has funded more than 40 publications, eBooks (both dedicated and produced in support of the print publications), and productions/exhibits. In addition, it has funded a number of archival management projects including the University of Saskatchewan Huskie Athletics archival collection and Special Olympics Saskatchewan archival holdings.

This year the Sport History Committee was made up of the following individuals: Kelvin Ostapowich, Robb Elchuk, Don Steponchev and Erin Stankewich.

At the beginning of the 2024-2025 year, there was three active SHP projects – The Saskatchewan Games 50-year history project, which worked through Phase III on their overall project. And the Phase I research phases of SASKSKI – Para Adaptive Snow Sport and Waterski Wakeboard Saskatchewan.

2024-2025 Project Activity is as follow:

- **The Saskatchewan Games Council (SGC)** Is continuing Phase III of their project, which includes website development and updates.
- SASKSKI SASKI- Para Adaptive Snow Sports Completed Phase I which resulted in 35 interviews of athletes, builders and experts on Saskatchewan Para-adaptive snow sports, 120 scanned archives (news paper clippings, etc.) and a collection of 300 photos. All material will be narrowed down to develop both a non-fiction history book and a youth-focused book on the history of Para-adaptive snow sports in Saskatchewan as part of Phase II which they received a [portion of their funding for in 2024
- Waterski Wakeboard Saskatchewan Completed Phase I which included research, collection and digitization of materials, organized by decade. They also created a searchable database for all digitized material. Phase II funded was awarded that will go towards the development on a website timeline.

GOVERNANCE COMMITTEE REPORT 2024 – 2025

In 2024, the Governance Committee reviewed Board Committee placements, Sask Sport 'Safe Sport' Policy updates, and new board member recruitment.
